5. The bids will be opened in the presence of Bidders representatives who choose to attend at 03-10-2020 14:00 hours at the Office of Rolpa Municipal Executive, Liwang, Rolpa, Nepal.
6. Bids must be valid for a period of 90 of days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format in case of e-bid. Which shall be valid for 30 days beyond the validity period of the bid.

The bidder shall furnish a bid security from "A" Class commercial Bank with a minimum of NRs. 2,50,000. If the bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Nepal Bank at office account no. 07603000003000000001 (Office of Rolpa Municipality, Liwang, Rolpa).

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
